No More Paper Policies

There's been movement to eliminate the agent copy of personal lines policies. Most agencies do not receive a physical "agent's" copy of a policy anymore. They receive ACORD standard policy download to maintain current personal lines data in their management systems (although many carriers provide access to the full policy on their agency portals). With personal lines being almost exclusively direct bill, the carrier sends a printed copy of the policy to the policyholder.

The CGL and Swimming Pool "Pop-Ups" by VU Faculty

Q. "We have a plaster and tile company who contracted to clean, re-deck and plaster a 25-year-old pool. After draining the pool, cleaning it, decking, and waiting on tile before applying the plaster, very heavy rains came and the pool raised 6 inches out of the ground. The insurer denied the claim based on the while performing work PD exclusion J.(5). The insured was not on site when the damage occurred and I say he did not have the entire pool in his CCC. Had he been building this pool from the ground up, yes, and builders risk or installation coverage would have been in order. His contract for basically refurbishing an old pool for \$10,000 (pool value \$50,000) with builders risk coverage would have covered only his work and not damage to the existing structure. What are your thoughts?"

More than a year after President Obama signed into law the Homeowner Flood Insurance Affordability Act of 2014 (HFIAA), FEMA is still working on implementing changes to the NFIP and flood insurance rates across the country.

Ultimately, HFIAA "slows some of the rate increases mandated by Biggert-Waters, offers relief to some policyholders that experienced high rate increases when Biggert-Waters was implemented and adds additional surcharges and fees," explains Cassie Masone, vice president of flood operations at Selective Insurance Company of America.

Virginia Association of Insurance Agents in conjunction with Imperial PFS is offering a scholarship for (1) VAIA Property & Casualty Pre-Licensing course or (1) VAIA Property & Casualty Pre-Licensing Self-Study Package.

Scholarship funding is available for an employee of a member agency of the Independent Insurance Agents of Virginia. There will be two rounds of scholarship offerings in 2015, one in the spring and one in the fall.

Scholarship Guidelines:

- Scholarship funding is available for the cost of (1) VAIA Property & Casualty Pre-licensing course or (1) VAIA Property & Casualty Self-Study Pre-Licensing package for an employee of a member agency of the Independent Insurance Agents of Virginia.
